- We agree that “ending demand” through tactics of increased policing and criminalization of those patronizing consenting adults in the sex trade is a harmful practice. Freedom Network USA opposes anti-trafficking efforts which focus on “ending demand” for consensual commercial sex.
- We agree that not all people who work in the commercial sex industry are trafficked.
- We agree that agricultural workers are vulnerable to trafficking and that H-2A visa holders should be able to change employers.
- We promote a human rights-based approach to human trafficking.
- We agree that each victim of human trafficking deserves explanation and access to the full range of reproductive health services (including legal abortion and birth control).
- We believe that immigrant workers should be protected through ensuring safe working conditions, preventing discrimination including sexual harassment, preventing workplace violence including sexual assault, eliminating wage theft and fraud, and barring exploitation and human trafficking.

**The applicant understands that Associate Members are required to:**

- a. Support the Freedom Network USA Trafficking Definition, Mission Statement and Principles (included);
- b. Engage in advocacy on behalf of, or provide services to, trafficked persons;
- c. Pay annual dues of \$250 (for organizations with budgets of more than \$100,000 in the previous fiscal year) or \$150 (for organizations with budgets of less than \$100,000 in the previous fiscal year);
- d. Submit a signed FNUSA Principles and Membership Agreement; and
- e. Submit a signed FNUSA Membership Confidentiality Policy.

**The applicant understands that members are expected to:**

- a. Attend the annual conference (in the Spring);
- b. Attend the annual meeting (usually the day after the conference); and
- c. Actively participate in at least one committee.

**Termination Clause:**

Freedom Network USA reserves the right to terminate Associate Membership at any time and for any reason, including an organization's failure to align with Freedom Network USA policies and principles and/or failure to complete the enumerated responsibilities of Associate Membership. Associate Members may terminate their membership in the Freedom Network USA at any time and for any reason, including misalignment with the Freedom Network USA's principles and positions or when responsibilities of Associate Membership become too burdensome to complete.

- All human beings have the right to live free from forced labor, slavery or servitude.
- All trafficked persons have rights, even if they are undocumented or hold false papers.
- All trafficked persons have the right to become empowered through the receipt of culturally-sensitive, victim-centered services, support and training.

As an Associate Member of the Freedom Network USA it is my responsibility to:

- Attend the annual conference.
- Actively participate in at least one committee.
- Pay yearly dues.
- Stay active and involved.
- Stay on message:
  - Human trafficking is modern-day slavery that encompasses both labor and sex trafficking.

  - We view human trafficking as a human rights issue with the goal of restoring rights and dignity to ALL survivors and providing services that empower and increase access to protection and assistance.

Therefore, all Members must abide by the following confidentiality provisions in all communication between Members.

### **CORRESPONDENCE**

- All correspondence sent or received through Freedom Network USA communication platforms (email, discussion forums, conference calls, etc.) are only intended for the professional use of FNUSA Members. You may not copy or distribute messages from the FNUSA to those who are not members of the FNUSA without express permission.
- Only communications clearly designated as approved for distribution outside of the Freedom Network USA Membership are allowed to be forwarded. These communications should be marked with statements such as, “Please Forward Widely” or “Please Forward Outside of FNUSA”. All correspondence not given this designation are confidential and are only to be forwarded within the FNUSA Membership without express permission from the author.
- Materials such as Committee Meeting Minutes, notes, and draft policy statements that are sent to the FNUSA Membership are highly sensitive and are never to be forwarded outside of the FNUSA Membership.
- All documents (papers, spreadsheets, charts, etc.) sent by Members of the Freedom Network USA are confidential and no document shall be forwarded outside of the FNUSA Membership without express permission from the author. These documents should be marked with statements such as, “Please Forward Widely” or “Please Forward Outside of FNUSA”.

### **MEETINGS**

All Freedom Network USA meetings, by electronic means or in person, including General Membership meetings, and Committee meetings are confidential. Nothing discussed during these meetings is to be divulged to those outside of the FNUSA Membership.

### **REPRESENTATION of the FREEDOM NETWORK USA**

- FNUSA Members shall not officially represent FNUSA unless given permission to do so. Permission must be obtained by the FNUSA Executive Director.
