International Labor Recruitment Working Group (ILRWG) is the first coordinated effort to strategically address abuses in international labor recruitment across visa categories. The Working Group is comprised of organizations working in various industries and with workers with a wide variety of visa types. The Working Group seeks to end the systemic abuse of international workers who are recruited to the U.S., by collaborating across labor sectors to develop comprehensive policies and advocate for reforms, including increased enforcement of existing laws and increased transparency in the labor recruitment process. The formation of the Working Group represents a transformational shift in the conceptual framing of guest worker protections: one that recognizes the systematic abuses in the recruitment of foreign workers as a form of economic coercion.
